



## **SDMIMD MERIT CUM TUITION FEE SCHOLARSHIP**

### **FOR THE TWO-YEAR POST GRADUATE DIPLOMA IN MANAGEMENT (PGDM)**

Following are the main features of the SDMIMD Merit cum Tuition Fee Scholarship (Code: MTFS):

1. Sons and daughters of parents (Father & Mother both) whose annual income is less than Rs. 8.00 lakhs from all sources shall only be eligible.
2. The waiver is limited to the Tuition Fee only. All other Fee except Tuition Fee will have to be paid by the beneficiary student.
3. The eligible candidates have to apply for PGDM in our website through the following <https://www.sdmimd.ac.in/application/online.html>
4. After submission of online application and payment of application fee, scanned copy/ pdf copy of the following documents are to be sent to [admissions@sdmimd.ac.in](mailto:admissions@sdmimd.ac.in) with the subject of the email to read as “APPLICATION FOR PGDM UNDER MTFS“
  - a. Application for Tuition Fee Scholarship signed by the Applicant
  - b. Declaration by Parents regarding Income in the annexed format.
  - c. Copies of Income Tax Return filed for the last two years
  - d. Salary Certificate/ Pay slip – self-attested (attested by the respective employees) – in case of parent/s who is employed.
  - e. Declaration regarding exemption from Income Tax (duly signed by individual parent in whose case he/she is not IT Assesse.
  - f. Original Certificate of Income issued by Tahsildar/ Competent Authority in case the parents are not income tax assesses.
5. The applications are to be submitted on or before 20<sup>th</sup> July 2025.
6. The Application for TFW and other formats are in the annexure.
